# Information Item for the membership of the Oklahoma Academy of Science (from Ken Hobson, Craig Clifford, Ulrich Melcher, and Connie Murray)

For many years, the OAS has been governed by an elected president and secretary and a board of sectionally chosen chairs and vice-chairs providing direction and oversight of an appointed executive secretary-treasurer. The operational face and fiscal officer of the society has been the executive secretary treasurer. The academy has grown very dependent on the person who serves in this position for the day to day business of publishing our journals, organizing meetings and processing memberships and records. Currently, these tasks are carried out by David Bass. We propose that the title of this position be changed to Executive Director to more accurately describe its expanded role in the society. We invite your comments regarding this proposed change which we will adopt immediately pending Executive Council consideration at the next regularly scheduled meeting.

### **Publication of Papers**

For the *Proceedings of the Oklahoma Academy of Science* (POAS) to be sent to the printers by early January with an anticipated publication date of around January 20, the following deadlines will need to be imposed. Manuscripts and notes must be received by the editor on or before August 15 (if the 15<sup>th</sup> is a Saturday or Sunday, then the following Monday) for peer review. Authors are being asked to submit a copy of the manuscript electronically to <a href="mailto:kurtisk@cameron.edu">kurtisk@cameron.edu</a>. Electronic submissions and reviews would expedite reviews. Peer reviewers are given approximately 6 weeks to review assigned manuscripts. To allow for author changes and for both the copy and layout editors to prepare for the journal printing, manuscripts and notes must be received by November 5 to be printed in that year's journal. Abstracts received for print must be received on or before the Fall Technical meeting. Other items such as Academy business, proceedings policies, financial statements, Letters to the Editor, and award announcements must be received by November 15. A goal is to have the journal mailed to members by the end of January.

Manuscripts and notes are peer-reviewed. However, even though abstracts are not peer-reviewed, they must align with the policies of the *Proceedings*. The substance of the abstract must fall within the scope of the *Proceedings*. Even though the quality or relevance of the work may not be in question, the printed material is subject to scientific accuracy. The same guideline applied to manuscripts and notes submitted for peer-review also apply to abstracts submitted for print. Manuscripts and notes are subject to thorough testing. The *Proceedings* understands that all disciplines are in a search for a deeper understanding of the world some of which are through creative expression and personal interpretation. Science is a system by which one discovers and records physical phenomena, dealing with hypotheses that are testable. The domain of "science" while working within nature is restricted to the observable world. There are many valid and important questions to be answered but lie outside the realm of science. The abstract must provide evidence that supports a conclusion.

Please contact the editor if you wish to be a manuscript reviewer. The editor is building a data base of reviewers and would like to do more of the manuscript transmittals electronically.

Congratulations to all undergraduate students who presented a paper or poster at the 2009 Annual Technical Meeting at East Central University and participated in the Oklahoma Collegiate Academy Competition.
